- 3. AND WHEREAS, as directed by the Hon'ble CAT, Chennai the representation of the applicant dated 6.6.2016 has taken up for consideration;
- 4. AND WHEREAS, meeting of the Departmental Promotion Committee was held on 19.6.2015 to fill up the 5 vacant posts of Principal Group "B"- Gazetted and each one vacant post of Training Officer and Assistant Director (Training) by promotion from the feeders cadre of Group Instructor / Surveyor-cum- Technical Assistant/ Assistant Training Officer and the following officials were considered for promotion to the post of Principal Group-B / Assistant Director(Training) / Training Officer in the order of merit under normal zone of consideration:

- 5. AND WHEREAS, 13 point reservation roster was maintained to fill up the promotion post as the total number of posts in the cadre of Principal Group B / Training Officer / Asst. Director (Training) is less than 14 and as per the 13 point reservation roster, the 7<sup>th</sup> point is earmarked for SC category:
- 6. AND WHEREAS, while filling up of the post, 7<sup>th</sup> SC point was accommodated by Thiru. M. Arputhanathan, Group Instructor, who belongs to SC category and however, Thiru. P. Murugaiyan, Group Instructor, who placed at 6<sup>th</sup> point Un reserved category, had already exercised his option for promotion to the post of Inspector of Factories in the Factories Wing as he was possessed the qualification of degree in Mechanical Engineering and his request was considered as one time relaxation and promoted to the post of Inspector of Factories. Due to which Thiru M. Arputhanathan, GI who hold 7<sup>th</sup> point SC category has moved to the 6<sup>th</sup> point under UR category and as such the 7<sup>th</sup> point was filled up by Thiru S. Prabagar Group Instructor who was next junior to Thiru M. Arputhanathan under UR category.
- 7. AND WHEREAS, Thiru. M. Aruputhanathan, who belongs to SC category was promoted to the post of Principal Group B w.e.f. 1.9.2015 against the UR category on own merit, subsequently retired on superannuation w.e.f. 31.5.2016 and action is being taken by this department to fill up the vacant post of Principal Group B as per the Reservation Roster.

NOW, THEREFORE, in total obedience to the Hon'ble Tribunal's Order dated 28/08/2017, the representations dated 6.6.2016 made by applicant has been taken up for consideration and action is being taken by this department to fill up the vacant post of Principal Group B (Gazetted) by promotion as per the Reservation Roster.
