**ORDER**

**Sub: Labour – Grant of Motor Conveyance Advance for the Purchase of a new TVS Moped XL Super to Thiru. S. Mariyappan, Peon, O/o the District Employment Exchange, Karaikal – Sanction – Accorded.**

Sanction of the Principal Secretary to Govt. (Labour) is conveyed for the grant of an advance of ₹.20,000/- (Rupees twenty thousand only) to Thiru. S. Mariyappan, Peon, O/o the District Employment Exchange, Karaikal for purchase of new TVS Moped XL Super from M/s. Sakthi Auto Agencies, No.113, Thirunallar Road, Karaikal-609 602 on first occasion. The advance shall be recovered in 50 equal monthly instalments @ ₹.400/- each commencing from the first issue of the pay or leave salary or subsistence allowance as the case may be after the advance is drawn. The amount of interest calculated in accordance with Rule 25 of compendium of Rules on Advances to Government Servants, should be recovered after the complete repayment of the advance.

2. The vehicle should be purchased within one month from the date of the drawal of advance failing which the full amount of advance drawn with interest accrued thereon shall be refunded to the Government as laid down in Rule 28 of Compendium of Rules on Advances to Government Servants.
3. It is certified that the grantee has the capacity to repay the above advance.
4. The conditions stipulated in Government of India's decision No.2 under Rule 28 of Compendium of Rules on Advances to Government Servants should be fulfilled before the advance is actually drawn.
5. The Registration Certificate and Cash Receipt of the vehicle purchased should be furnished within one month from the date of purchase of the Vehicle or within two months from the date of drawal of advance, whichever is earlier, as per Compendium of Rules on Advances to Government Servants, failing which, the grantee shall be liable to pay penal interest on the entire amount of advance from its date of drawal to the date of submission of the Registration Certificate.
6. If there is any irregularity in repayment of Principal or interest, or the conditions attached to the sanction are not fulfilled to the satisfaction of the competent authority, 2.5% interest will be levied above the prescribed rate of interest, as per Compendium Rules on Advances to Government servants.

7. The advance is debitable to the Head of Account "7610 - Loans to Government Servants, etc., - 202 - Advance for purchase of Motor Conveyance - 202 (02) Advance for purchase of the Other Motor Conveyance 202(02) (07) all Regions (55)/Loans and Advances (Non-Plan)" in the Budget of the Current financial Year.

8. The Finance Department has certified the availability of funds vide their I.D.No.1331/MCA/2010/F1/(A) dt. 27.09.2010.
