NOTIFICATION

Whereas, the draft rules seeking to amend the Puducherry Factories Rules, 1964, was issued in the Government of Puducherry, Labour Department's Notification under G.O.Ms.No.06/AIL/Lab/G/2022, dated 31st May 2022 and published as required under sub-section (1) of section 115 of the Factories Act, 1948 (Central Act 63 of 1948), in the Extraordinary Gazette Part –II, No.31, dated 12th July 2022 of the Government of Puducherry inviting objections and suggestions, if any, from all persons likely to be affected thereby;

AND WHEREAS, no objection or suggestion has so far been received from any quarter in this regard;

NOW, THEREFORE, in exercise of the powers conferred under section 112 of the Factories Act, 1948, the Lieutenant-Governor, Puducherry, hereby makes the following rules further to amend the Puducherry Factories Rules, 1964, namely:-

- 1. Short title and commencement: (1) These rules may be called the Puducherry Factories (Amendment) Rules, 2023.
