NOTIFICATION

WHEREAS in the D.O. letter No.G-32/11/6/161/2014-ISD (Dhanwantri), dated
19.11.2014 received from the Director General, ESI Corporation, New Delhi, it was stated that
in the 162nd meeting held on 31.07.2014, the ESI Corporation has approved for setting up of
an institutional mechanism in order to empower the States and strengthen the review and
monitoring of the Medical Care Delivery System under the Scheme.

AND WHEREAS in order to monitor the implementation of "Dhanwantri Module" the
ESI Corporation, New Delhi has requested to constitute a State Executive Committee under
the Chairmanship of Secretary to Government(Labour) / Health;

2. Accordingly the Lieutenant- Governor, Puducherry is pleased to approve the
constitution of the State Executive Committee with the following composition:

3. The powers and functions of the State Executive Committee in respect of ESI Hospital/Dispensaries are as follows:-

- (i) It shall meet once in three months.
- (ii) To ensure availability of medical and paramedical man power. MS
- (iii) To ensure availability of equipment. MS
- (iv) To ensure availability of drugs. MS
- (v) To monitor functioning of IMPs through periodic review of the reports of the Local Committees as well as independent inspections.
- (vi) To monitor super speciality treatment bills. MS
- (vii) To approve empanelment, de-empanelment, back listing etc. of the tie-up hospitals for secondary care. (No referrals or pre-approvals for patients being referred to tie-up hospitals for secondary care would be routed through SMC for any reasons whatsoever).
- (viii) To approve empanelment, de-empanelment, backlisting of hospitals for super speciality treatment based on the proposal submitted by SSMC/SMC as per the approved policy of the ESI Corporation.
- (ix) To monitor payment of bills of hospitals having tie-up for secondary treatment. DD BS
- (x) To monitor implementation of IT Roll out under Project Panchdeep in the State, including power back-up issue. DD
- (xi) To monitor training of ESIS officials. DD
- (xii) To monitor infrastructural issues and execution of repair work; i.e. to monitor timely survey of all the ESIS building and getting proposals for repair, reviewing of rented premises of ESIS dispensaries.
- (xiii) To submit reports/returns and /or any proposals to National Level Committee headed by the DG, ESIC for further action/consideration.
- (xiv) For special repairs & annual repair and maintenance the financial powers as and when delegated to the State Executive Committee.
