#### NOTIFICATION

In exercise of the powers conferred by sub-section (1) of section 10 of the Contract Labour (Regulation and Abolition) Act, 1970 (Central Act 37 of 1970), the Lieutenant-Governor, Puducherry, after consultation with the Puducherry State Contract Labour Advisory Board, Puducherry and having regard to the conditions of work and other benefits provided for the contract labour and other relevant factors specified in sub-section (2) of the said section, hereby prohibits the employment of contract labour in the process, operation or the works specified in the schedule annexed hereto, in all Non-Metallic Product Industries (i) Bottle Making (ii) Granite Cutting and (iii) Polishing Industries existing in the Union Territory of Puducherry with effect from the date of the publication of this notification in the Official Gazette:-

Process in which contract labour is prohibited

- (a) Raw material sieving
- (b) Raw material handling and Ball Mill mixing
- (c) Furnace /Kiln area
- (d) Bottle making
- (e) Drying section
- (f) Cutting /Polishing of stones
