NOTIFICATION

In exercise of the powers conferred by the proviso to article 309 of the Constitution of India, read in the Notification No. F.5/4/65-GP,dated 11th January 1965 of the Ministry of Home Affairs, Government of India, New Delhi and in supersession of the Notification issued in G.O.Ms.No.26/90/Lab., dated 3rd April 1990 of the Labour Department, Government of Puducherry and published as the supplement to the Gazette No.16 dated 17th April 1990, save as respects things done or omitted to be been done before such supersession, the Lieutenant-Governor, Puducherry hereby makes the following rules, regulating the method of recruitment to Group 'C' Non-Gazetted post of Woman Labour Welfare Officer in the Labour Department, Puducherry, namely:-

1. Short title and commencement:— (i) These rules may be called the Government of Puducherry, Labour Department Group 'C' Non-Gazetted post of Woman Labour Welfare Officer Recruitment Rules, 2023.

- (ii) They shall come into force on and from the date of their publication in the official gazette.
- 2. Number of posts, their classification and Level in the pay matrix: The number of the said posts, their classification and level in the pay matrix attached thereto, shall be as specified in the columns (2) to (4) of the Schedule annexed hereto.
- 3. Method of recruitment, age limit and other qualifications:— The method of recruitment to the said posts, age limit, qualifications and other matters relating thereto, shall be as specified in columns (5) to (13) of the Schedule.
 - 4. Disqualification:- No person, -
- (a) who has entered into or contracted a marriage with a person having a spouse living; or
- (b) who, having a spouse living, has entered into or contracted a marriage with any person shall be eligible for appointment to the said posts.

Provided that the Lieutenant-Governor, Puducherry may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and there are other grounds for so doing, exempt any person from the operation of this rule.

5. Power to relax – Where the Lieutenant-Governor, Puducherry is of the opinion, that it is necessary or expedient so to do, he may, by order and for reasons to be recorded in writing, relax any of the provisions of these rules with respect to any class or category of persons.

6.Savings – Nothing in these rules shall affect the reservations, relaxations in upper age limit and other concessions required to be provided for the scheduled castes, the scheduled tribes and other special category of persons in accordance with the orders issued by the Government from time to time in this regard.
